SOME THOUGHTS ON GIVING

Some time ago, I penned a note to my granddaughter Savannah. I wanted to share some thoughts on life with her. Life is something like a passenger train, I wrote. She and I have come on board at different points, and we will disembark, each in our own time. But for a while, we will be along for the ride together. This thought has come to mind as I share some ideas about giving as someone who has been on this train for a while now.

Dana Holt, writing in a Luther Seminary article entitled "Strategic Giving for Retirees," poses the question, "How much should we give after we retire and don't have regular income from work anymore?" Most retirees live on Social Security income along with some form of pension or investment income, including IRAs (Individual Retirement Accounts).

Those of you who have been on the "train of life" as long as I have know we are required to take yearly distributions from our IRAs, referred to as RMDs (Required Minimum Distributions), beginning at 70½ years. These distributions are virtually 100% taxable. Until recently, people have had no choice but to withdraw these RMDs and pay the corresponding tax.

Well, today you and I have a choice. We can give some or all of an RMD to our favorite charities and avoid those costs. This is called – more alphabet soup – a QCD (Qualified Charitable Donation) and is becoming an effective option.

Holt points out some of the finer points of QCDs:

- Must be 70½ or older at the time of the transfer
- May contribute up to \$100,000 per year, per IRA owner
- Not taxable to IRA owner or to charity
- Must be sent directly from IRA custodian to charity
- Only applies to IRAs – not 401(k), 403(B), etc.

So a QCD is probably the most tax-efficient way for retirees over 70½ to give to charity. And that's what my wife Sharon and I did this year with our commitment to Holy Trinity. We decided to fulfill our pledge early in the year with a direct gift from our IRA income.

My dad used to cash his weekly check, and—first thing—fill up the coming Sunday's offering envelope. Our early gift this year felt just like that—first fruits of that which we have been blessed.

Dana Holt also reminds us that congregations can be named as a partial or full beneficiary of an IRA, so that our support for our church can continue after we get off the "train of life."
